SUMMIT HIGHLIGHTS

MULTI-CULTURAL GROUPS CONNECT ON SOLUTIONS FOR ORAL HEALTH DISPARITIES

Boca Raton, FL - A historic meeting of three ethnic minority dental organizations convened in Boca Raton, FL, July 20-24, 2012. The first ever joint convention was hosted by the National Dental Association (NDA), Hispanic Dental Association (HDA), and Society of American Indian Dentists (SAID). The groups were brought together out of a common concern about access and disparities that disproportionately affect communities of color. Billed as the “Multi-Cultural Oral Health Summit” the theme of the conference was, *“Collectively Meeting the Needs of a Diverse Population to Improve Oral Health”*.

Multi-Cultural Oral Health Summit Highlights:

ADA hosted a Leadership Development session for Board members of the NDA, HDA, SAID, and ADA. All four boards met together for association governance session facilitated by Josh Mintz, with presentations by Derrick Humphries, Legal Counsel of the NDA and J. Craig Busey, Legal Counsel of the ADA. The groups engaged in roundtable discussions, shared best practices, and vowed to hold subsequent joint meetings; and to support each other’s progress.

The Opening Session included ethnic presentations representing the traditions of all three cultures. Collectively, the groups presented awards to individuals whose companies have been instrumental in promoting the growth and viability of the three organizations. The award recipients were: **Ian Cook, President, Colgate; Ivan Lugo, VP, Procter & Gamble/Crest-Oral-B; Stanley Bergman, CEO, Henry Schein, Inc.; and Faye Donohue, President, DentaQuest.** Also in attendance were representatives from other organizations, academic institutions, the dental industry, government agencies, and community partners.

The Multi-Cultural Summit included joint Continuing Education courses as well as concurrent sessions not only of the three dental groups, but also of: the Students of the NDA, HDA, and SAID; the Dental Assistants and Dental Hygienists of the HDA, NDA, and SAID; and the Minority Faculty and Administrators. A popular feature was the New Dentists’ Conference.

The Presidents’ Symposium, a two part session, underwritten by the DentaQuest Foundation, was one of the signature events of the Summit. Part 1 was entitled, “Multi-Cultural Challenges for Health Care and Issues Surrounding Oral Health.” The moderator was Dr. Joyce Reed, faculty leader from Harvard Medical School. The presenters whose presentations focused on the issues in vulnerable communities were: Dr. Sarita Arteaga (HDA-Hispanics); Dr. Caswell Evans (NDA-African American); and Dr. George Blue Spruce (SAID-American Indians). The title for the President’s Symposium Part 2 was, “Oral Health Center Stage: The Media and Multi-Cultural Messaging.” The presenters and their topics were: Ms. Linda Organ (CDC Communications Specialist), “Community Water Fluoridation. Benefits and Concerns for Ethnic Minorities”; Brian Swann, DDS, MPH (Harvard), “Dentists as Oral Physicians and Inter-professional Team Leaders”; Anne Marie O’Keefe, JD, PhD (Morgan State University), “Using the Media for Health Messaging”; and Ms. Sheri Klein (Advertising Council), “The Ad Council’s First-Ever Oral Health Campaign.” A special attendee at both sessions was the Honorable Dr. Louis Sullivan, former US Secretary of Health and Human Services.

The sessions were designed to present issues and concerns common to the host organizations and the communities they serve; to introduce attendees to the importance of using the media for

health messages; and to demonstrate the impact of collaborative message development.

This health-focused festival offers attendees access to free oral exams and education on oral health.

The NDA™, based in Washington D.C., represents the priorities of over 10,000 African American and minority dentists, as well as dental students, dental hygienists, dental assistants and auxiliaries across the country. The National Dental Association mission speaks directly to providing access to dental service for underserved communities, and education and advocacy for its members. "The Take a Loved One to the Doctor" message will be carried on over 105 stations, reaching 8 million listeners, when Joyner launches the event with a 6am-10am ET live broadcast on site. Attendees will experience a live broadcast on Friday, October 19th at 6 a.m., featuring **Tom, Sybil Wilkes, J. Anthony Brown, Jacque Reid & Roland Martin** as well as national artist performances and interviews with today's top health experts.

The National Dental Association has designated The New Era Dental Society, the NDA's award-winning Philadelphia chapter, as its local host. The **DENTAL ZONE** will be designed under the leadership of NDA member dentists Drs. Joan Malcolm, Glenn Brown, Renee Dempsey, Arnelle Lloyd, and Charmen Douglas. The NDA local chapter has enlisted the support of NDA member dentists in Philadelphia, NJ, MD and DE. The NDA also has engaged other community partners, including: the Links, Incorporated, the University of Pennsylvania, Temple University, the University of Medicine and Dentistry of New Jersey, the Greater Philadelphia Health Action, the Southern Jersey Medical Centers, and the Oral Health Academy.

The **DENTAL ZONE** will include mobile dental units and portable dentist chairs for screenings, a "Children's Corner", "Ask the Experts" kiosks with dentists, physicians, and pharmacists; free dental product donations, information for adults, oral cancer screenings, referrals to area providers, and special dental information for senior citizens and their care givers.

NDA President-elect, Dr. Edward Chappelle Jr., will participate in Tom Joyner's Town Hall meeting, and stated, "The program is a tribute to the commitment of Tom Joyner to total health; and his awareness about the important link between oral health and overall health. The NDA is proud to be a part of this nationwide effort and to contribute to increasing dental health literacy in African American communities and vulnerable populations."

Kentucky SNDA Chapters Launch 1st Annual Oral Cancer Walk

In the Spring of 2012, the SNDA chapters of the University of Kentucky College of Dentistry and the University of Louisville School of Dentistry partnered to organize the UK and UofL First Annual Oral Cancer Walk. The Walk/Run took place at the Coldstream Park in Lexington, KY. Participants in the event not only walk or run, but were able to learn more and be screened for Oral Cancer. The Oral Cancer Walk was made possible through the generous donations of Delta Dental of Kentucky, the Kentucky Dental Society, the Bluegrass Dental Society and many others. Over \$6,000 was raised during this first walk. The money will be donated to the Head and Neck Cancer Alliance as well as to the University of Kentucky Markey Cancer Center to help further education and research on oral cancer. The Second Annual Oral Cancer Walk is already in the planning for next spring in Louisville.

Fayetteville, NC - NDA members from North Carolina's Old North State Dental Society (ONSDS) partnered with the NC Dental Society's North Carolina Mission of Mercy Project (NCMOM) to provide free adult dental care at the Crown Agri-Expo Center in Fayetteville, NC, on Friday, June 20, 2012. This was the first NCMOM program in Fayetteville, and there was overwhelming demand. On the day of the event, registration was cut-off at 6:30a.m. , ½ hour after the doors opened, with 700 persons registered. The ONSDS dentists were part of a team that included 80 portable dental chair/units, 57 dentists, dozens of hygienists, scores of assistants, and hundreds of support staff volunteers. The patient roster ranged from the homeless and long-term unemployed to people with jobs who can't afford dental insurance. Since it's founding in 2003 through the end of 2011, the NCMOM has provided more than \$14.5M in free dental care to over 37,000 Carolinians.

NDA and SNDA “Impress” High School Students in Cleveland

Thirty-one area high school students who aspire to be dentists, physicians, scientists and other healthcare professionals graduated recently from Cleveland Clinic’s Charles R. Drew Saturday Academy.

In collaboration with Health Legacy of Cleveland, Incorporated, Saturday Academy was founded five years ago as an educational enrichment program designed to increase underrepresented high school students’ interest in a career in healthcare. Health Legacy is an organization that works to increase the number of underrepresented minority physicians, researchers and dentists in northeast Ohio.

A 12-week program, Saturday Academy provides students with career information and skills to prepare for professional education. Students learn from experienced healthcare professionals through hands-on learning and individualized mentorship. Upon successful completion of the program, participating students receive a stipend.

The Saturday Academy program has graduated 147 students.

On one Saturday, the students visited Case Western Reserve University School of Dental Medicine

for the Student National Dental Association’s (SNDA) Impressions Program. Students participated in hands-on simulations, practiced applying sealants to teeth, learned to identify teeth visually and by name and toured parts of the dental labs and clinics.

Health Legacy board member, National Dental Association (NDA) Secretary and Cleveland Dentist, Madge Potts-Williams, DDS, organized the Inaugural Dentistry Day Program. “We planned this day with the help of the school’s Chapter of the Student National Dental



Association (SDNA), chaired by rising senior Ashlee Goodman. The SNDA’s Impressions Program is presented at Dental Schools across the country where there is an SNDA Chapter”, said Dr. Potts-Williams. “In addition to the experiential activities conducted by the SNDA students, and lectures by Dr. Mickel and myself, the high school students interacted with our Case students and learned how they prepared for college and dental school.”

NDA members and Health Legacy Board Members, Roderick H. Adams, Jr., DDS, James H. Houston, DDS, and Andre Mickel, DDS, Chairman of the Department of En-

dentodontics at Case Dental, and the President of Health Legacy’s Executive Committee also mentored the students. Eugene Jordan, DDS, President of Forest City Dental Society and Past President of the NDA, lent his support during the program.

Four students, as a result of this program, expressed a desire to pursue dentistry as a career. High school senior Brandon Smith noted he was inspired to pursue his early childhood dream of becoming a dentist. Brandon said he applied to Saturday Academy because peers who participated in the program before him, said, “It is a great experience for someone adamant about going into the medical field.”

Saturday Academy is named in honor of Charles R. Drew, MD. Dr. Drew was an African American surgeon and medical researcher who pioneered improved techniques for blood storage which he used to help develop large-scale blood banks during World War II. 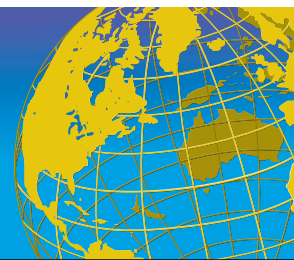

AETNA Foundation Funds Joint MED/DENT C.E. Programs in Kentucky and Louisiana

The Kentucky Dental Association and the Pelican State Dental Society hosted joint continuing education programs for physicians, dentists, and other health professionals in April and June, 2012 (respectively). The programs were supported by an educational grant from the Aetna Foundation to the NDA, which focuses on integrated health and inter-professional training. All NDA Chapters are eligible to apply for the mini-grants, and in addition to the societies in Kentucky and Louisiana, the other chapters who were awarded grants in 2012 are: The New Era Dental Society (Philadelphia) and the North Georgia Dental Society (Atlanta).

Dr. Carrie Brown, President of the Kentucky Dental Society, presided over the organization’s first “Linked for Life” joint medical and dental CE course – “Periodontal Disease and Its Affect on Systemic Diseases and Pregnancy”. Attendees included dentists, physicians, hygienists, dental assistants and dental students. Guest speakers included Drs. Thomas Wayne (Cardiologist), Mark Thomas (Periodontist), Vinnette Little (Internal Medicine), and S. Steele (OB Gyn). VOCO Rep., Ms. Renee Henderson was also in attendance.

Other NDA local chapters who hosted joint programs in 2012 were the Old North State Dental Society (North Carolina) and the Maryland Dental Society (Baltimore). The Alabama Dental Society (Birmingham), and Robert T. Freeman Dental Society (Washington, DC metro area) were awarded grants in previous years.

Dentist Advantage 2Q Update

The modest rate increase of about 7.5% that Dentist’s Advantage is implementing is on target to launch in the 3rd Quarter of 2012. About 40 state insurance departments have approved the filing and we are continuing with the systems work needed to implement this change.

Fortress

We have seen that Fortress Insurance has filed for a 11.8% rate increase in Pennsylvania. Fortress typically strives to have the lowest price point in a given market. Clearly they are experiencing the frequency and severity of claims that we would expect them to have.

The Dentists Insurance Company

Interestingly, we have seen a news report by the Director of Communications for TDIC in California that TDIC has: “worked with the [state insurance] department to achieve its rate reduction of 13.42%”

From the way the article reads, it seems that TDIC was requesting an increase but the state insisted on a reduction. Clearly this may have some implications for Dentist’s Advantage in California. We will continue to monitor and report on this situation.

National Society of Dental Practitioners

The NSDP held its annual Board Meeting in late March.

The founder of the NSDP and President of the Board, Burton Pollack, DDS, JD, announced his retirement at the meeting. He was immediately elected President Emeritus and he agreed to a one-year term in this new role. The new President of the NSDP Board is yours truly. I was surprised and humbled to be nominated by one of the dentist board members. I expect to continue to work with the NSDP Board to provide NSDP members/Dentist’s Advantage clients with quality risk management information that will assist them in their day-to-day practice.

You may recall that one of the features the NSDP provides its members is access to a Hotline. In 2011 the NSDP Hotline took 964 phone calls! This is nearly a 20% increase over calls in 2010. These Hotline calls are currently handled by two dentists. As the volume continues to increase it is unreasonable to expect that two dentists will be able to handle all the calls. We are continuing to explore options to provide better service to our clients. We expect to announce some subtle changes to the Hotline in the coming months.

Policy Enhancements

Approvals are being received from many State Insurance Departments on the rate/rule filings Chartis has been making. As I mentioned above, a 7.5% rate increase has been filed. In addition to this increase in rates we will also be implementing several policy enhancements for the Program. For example:

- 75% premium credit for first-year dentists (though NY is pushing back on this one)
- HIPAA coverage - included with all professional liability policies at no charge
- Corporate Identity Theft coverage

Implementation dates are pending for all states since we are testing the system now to ensure that we will be able to process requests for these new endorsements. We expect to go-live with these changes as early as the 3rd quarter.

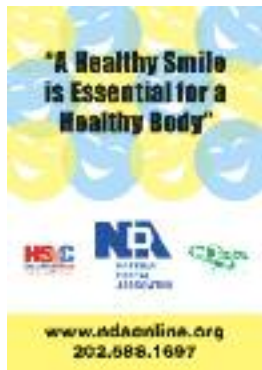

NDA and the GENERAL ELECTRIC AFRICAN AMERICAN FORUM LAUNCH PILOT PROGRAMS

The NDA and the General Electric African American Forum have begun planning community partnership programs in Houston and Baltimore. The two groups are collaborating to increase oral health literacy, increase access, and to introduce STEM (Science, Technology, Engineering, and Math) students to careers in dentistry in selected venues, such as elementary schools, middle schools, and Boys and Girls Clubs.

NDA-LINKS PARTNERSHIP LAUNCHES WITH SUPPORT FROM COLGATE AND SCHEIN

Schein and Colgate played a major role in launching the newly formed NDA partnership with the Links, Incorporated. Henry Schein Cares donated three thousand sample products, including Schein's "Total Health – Beyond the Mouth" educational brochures about the link between oral health and overall health, which were distributed in bags (see below) to all 3,000



attendees at the Links Annual Assembly, held in June 2012, in Orlando. This information, and the newly formed Oral Health Advisory Committee to the Links national Health and Human Services Committee, will

increase oral health literacy and advocacy among the Links grassroots membership base. Colgate Bright Smiles/Bright Futures conducted a community outreach program in conjunction with the annual meeting (Story on p. 6).

Sheila Brown, Sherae Farmer, Allison Riddle-Fletcher, Hazel Harper Johns, Jocelyn Kidd, and Madeline Anderson-Thomas. Dr. Jeanne Sinkford, NDA Life Member, Links Alumna, and former Dean of Howard University College of Dentistry (HUCD) initiated a partnership with the HUCD and her chapter, the Washington DC Chapter of the Links nearly 40 years ago. She stated, "I am elated to witness the evolution of this wonderful partnership."

In 2012, the NDA and Links chapters have collaborated in oral health projects that have been featured in community programs have in Chicago, Orlando, Prince George's County, MD, and Washington, DC. The groups will also partner in the upcoming the Tom Joyner Morning Show Take A Loved One to the Dentist Health Festival in Philadelphia, October 19-20, 2012. Planning is underway for additional programs scheduled in Dallas, Baltimore, and Houston.

NDA Receives Grant From Links Foundation for New Expansion Project

The Links Foundation awarded a \$25,000 grant to the National Dental Association to support the NDA in laying the groundwork for a national, community-based, mobile health expansion program in two pilot cities: Chicago and Dallas. The new program is called, “**NDA-HEALTH NOW**- *Health Equity. Access. Literacy. Technology and Hope. National Outreach on Wheels.*” Drs. Sheila Brown and Jocelyn “Tina Kidd, will spearhead the programs in Chicago and Dallas, respectively. The Project will target populations that are vulnerable and underserved, including: racial and ethnic minorities, including immigrants and non-English speakers; children; pregnant women; older adults and senior citizens; individuals in urban underserved areas; uninsured and publicly insured individuals; homeless individuals; uninsured and under-insured veterans; and general populations of lower socioeconomic status.

The goals of the project are to: 1) increase access, 2) improve health literacy, 3) promote prevention, and 4) eliminate dispar-

ities in vulnerable populations. **NDA-HEALTH NOW** will enlist the support of NDA members and galvanize community partners to achieve the project goals. The core components of NDA-HEALTH NOW include collaboration, service, education, research and policy. In addition to basic and continuing dental services, the proposed project will include medical and vision screenings. It will also expand its focus to include children, adults and senior citizens. Some of the proposed project features are: “mixed-use” mobile health units (equipped for medical, vision, and dental care); inter-professional workforce teams; affiliations with Federally Qualified Health Centers (FQHC), school-based health clinics, and public housing authorities; alignment with federally designated health shortage areas to recruit and deploy under-represented minority (URM) oral health professionals, including military veterans who will be targeted for training and employment.

NDA-LINKS/ Colgate Brush-a-Thon

Chicago, IL - The Lincoln Dental Society, a component chapter of the National Dental Association (NDA) partnered with the Lake Shore Chapter of the Links, Inc. and Colgate Bright Smiles/Bright Futures to host a “Brush-a-Thon” at the Calhoun North Elementary School on April 20, 2012. The event was spearheaded by Dr. Sheila Brown, Immediate Past President of the NDA, and a member of the sponsoring chapter, the Lake Shore Chapter of the Links, Inc.

The event’s theme was “Keep that Smile for a Lifetime” and was the first joint effort of the newly formed national partnership between the NDA and the Links, Inc. to increase awareness about the important connection between oral health and overall health. The “Brush-A-Thon” is an interactive, child-friendly, oral hygiene instructional program, which is a feature of Colgate’s award winning Bright Smiles/Bright Futures program that targets inner city children. The day’s events included: Colgate’s Dr. Rabbit’s oral health video, tooth brushing techniques, music and entertainment sponsored by 107. WGC mobile van and disc jockeys, goody bags with dental products, and a “Passport to Health” - a resource directory of area dental facilities.

Dr. Brown, who currently serves on the Links, Inc. Health and Human Services Facet, announced the NDA-Links collaboration at the Links Eastern Area Regional conference in Atlantic City, in April of 2011. During her announcement she stated, “I am elated that the Eastern Area has selected Oral Health as a major focus. The link between oral health and overall health is

one that has been overlooked for too long. The National Dental Association wants to join hands with you [the Links, Inc.] in your efforts to increase access and eliminate disparities. I am looking forward to NDA local chapters forging strong, enduring partnerships with Links local Chapters throughout the nation. The NDA has a ‘legacy of leadership and a tradition of service’ in the communities that need us the most.”

The NDA-Links, Inc. collaboration is an important component of the NDA national community health expansion project. “We have made ‘commitment to community’ a priority. NDA dentists come face to face with children, adults and senior citizens who are suffering from lack of dental care. We do not want others to pay the price that Deamonte Driver paid. Children and adults should not die from preventable dental disease,” added Dr. Brown.

Although there is a greater focus on oral health since the tragedy of 12 year-old Deamonte Driver, most people still don’t know that gum disease is linked to diabetes, heart disease, and low birth weight babies. Dentists are also concerned that the same things that contribute to obesity also contribute to tooth decay. The goal of the NDA is to partner with others in vulnerable communities to improve health literacy, increase health equity, and promote prevention. All health education must include oral health messaging. In the words of former U.S. Surgeon General C. Everett Koop, “America must understand that you cannot separate the mouth from the rest of the body; and that you cannot be healthy without good oral health.”
