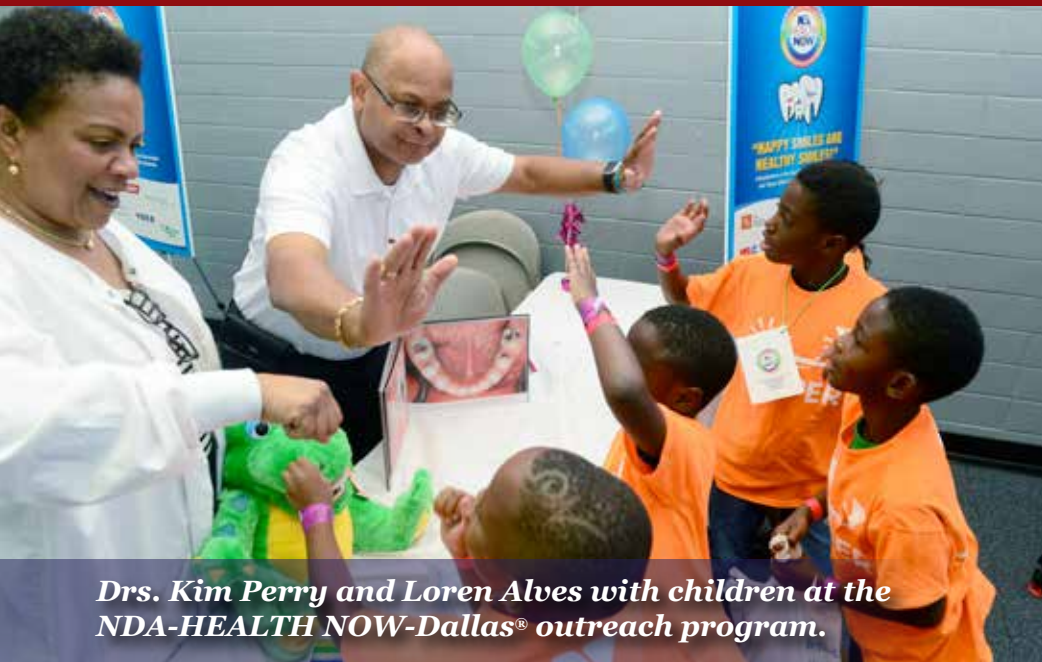

## NDA-HEALTH NOW-Dallas® Hosts event at NDA Convention



*On Wednesday, July 19, 2017, the National Dental Association (NDA) hosted a children's community service project, at the Baylor Scott and White Health and Wellness Center at Juanita J. Craft Recreation Center, as part of its 104th Annual Convention in Dallas, Texas.*

The health event was hosted by NDA-HEALTH NOW-Dallas® and the Gulf State Dental Association (the local chapter of the NDA) for the Center's Summer Camp children, as well as children from the surrounding community. The Dallas convention project was made possible with funding from the W.K. Kellogg Foundation, DentaQuest Foundation and Colgate. Other corporate partners are: Henry Schein Cares Foundation, Sunstar and VOCO Americas, Inc. Community partners are: Texas A&M College of Dentistry and the Dallas chapter of the Links, Incorporated. Volunteers also included the officers of the NDA and members of the Gulf State Dental Association.

The Center event included information on oral health education, nutrition and fitness, dental screenings, and STEM (Science, Technology, Engineering, and Mathematics). Colgate's Bright Smiles/Bright Futures van was on site to provide the children's dental screenings and fun with Dr. Rabbit, Colgate's mascot. NDA-HEALTH NOW® programs are currently active in seven partner cities: Chicago, Dallas, New York, New Orleans, Atlanta, Oakland and metro Washington, DC. The initiative provides resources and services to underserved communities to: 1) increase access to health care; 2) eliminate disparities; 3) increase health literacy; and 4) promote disease prevention.

NDA-HEALTH NOW® has formed strategic alliances with public school systems, Federally Qualified Health Centers (FQHCs), recreation departments, hospitals, senior citizen organizations, and other community health focused entities. It leverages the time, talent, and efforts of a massive network of volunteers from civic, social, and service organizations including fraternities and sororities. The focus is on total health and disease prevention and the community outreach programs feature all health professionals, including dentists, oral health professionals, physicians, optometrists, nurses, physician assistants, and pharmacists. Future plans include the purchase of

"mixed-use" mobile health units to provide medical, vision, and dental services for children, adults, and the elderly.

Since its inception in 2013, NDA-HEALTH NOW® has supported 100 programs in 15 cities and five countries. The programs, managed by dozens of community partners and volunteers, have provided oral health services and education to over 21,011 individuals, performed screenings and referrals for over 14,501 people, and applied fluoride varnish to 7,029 children. A cooperative agreement with the Henry Schein Cares Foundation allows the project to provide in-kind product donations to free clinics and global outreach programs in Africa, Haiti, Jamaica, Pakistan, and Greece. In July, 2016, NDA-HEALTH NOW® received the Power of A Award, a national award from the American Society of Association Executives.

## **BACK-TO-SCHOOL CAVITY FREE!**

### **NDA-HEALTH NOW-New Orleans® & NORD Commission Host Awards and Briefing Event**

*The National Dental Association (NDA) and the New Orleans Recreation Development (NORD) Commission co-hosted an Awards and Briefing Program for the Summer Campers “Back-to-School-Cavity-Free” (BTSCF) initiative at the Joe W. Brown Recreation Center, 5601 Read Boulevard, New Orleans, Louisiana, on Saturday, August 12, 2017, from 10:00 a.m. – 10:30 a.m.*

The event was held during the 2nd Annual NORD Commission “Back-to-School-Expo” and included a briefing on the 2017 program results. The BTSCF initiative, a collaboration of the New Orleans Recreation Development (NORD) Commission and the National Dental Association (NDA), was designed to provide preventive dental services and education for the city’s 4,000 summer camp enrollees and to send each camper back to school with happy smiles and a healthy head start. It consisted of a series of children’s oral health programs held in conjunction with NORD summer camp enrollment events and camp site visits from March 4, 2017 through August 12, 2017. The 2017 project was supported by the Louisiana Department of Health, the State Oral Health Coalition, the New Orleans

Health Department, and the Louisiana State Board of Dentistry. Project sponsors included: VOCO, Colgate, Henry Schein, Inc., Sunstar, the DentaQuest Foundation, Entergy Foundation, Hear to HEAL, Inc., and the Middle Collegiate Church. This project has been supported by a vast network of community organizations, businesses and volunteers including: Audio Visual Technology, Entergy, EXCELth, Inc., The New Orleans Dental Society, the New Orleans Chapter of the Links, Incorporated, Louisiana State University School of Dentistry, St. Mary’s Academy, University of New Orleans Pre-dental students, and dozens of volunteers.

Colgate’s Bright Smiles/Bright Futures van was on site at the Joe Brown Center on August 12th to provide children’s dental screenings. NDA volunteers were also onsite to provide

fluoride varnish applications, donated by VOCO, for children ages 5-11; as well as to distribute Resource Directories of Orleans Parish dental providers and information about children's dental plan enrollment. Awards were presented to all of the volunteers, and the Advisory Committee and sponsors received Congressional Appreciation Citations from Congressman Cedric Richmond (District 2 of LA). The A's and Aces Dillard University camp won the award and Zoo passes for all of next year's summer campers for being the camp that had the highest percentage of children participating in the program. One of the highlights of the Awards and Briefing Program was a film containing footage chronicling the growth and expansion of the NDA-HEALTH NOW® project from the early beginnings up until today. This film was made possible by funding from the W.K. Kellogg Foundation.

The "Back-to School-Cavity-Free!" program is administered by the National Dental Association under the NDA's signature project, NDA-HEALTH NOW® (Health Equity, Access, Literacy,

Technology, and Hope. National Outreach on Wheels.) It was conceived to address the national oral health crisis impacting vulnerable and underserved populations. In 2014, NDA-HEALTH NOW-New Orleans® was launched at the Treme Recreation Community Center. But since



that time, death from dental disease struck a popular New Orleans trumpeter, Travis Hill, who died while on tour in Japan from a dental infection that caused his heart to stop beating. Tooth decay is preventable.

Early education, diagnosis and prevention can stop the tragic consequences of untreated dental disease.

This year, thanks to their summer camp directors, children at 10 summer camps participated in the new Dental Health Day sessions- Royal Castle, YAYA Arts Center, Dillard U FIT, A's and Aces @ Dillard U, City of Love, VIET, A's and Aces @ Joe Brown Center, Hype Academy, Building a Better 2morrow, and Tamborine and Fan. Parents of those children requiring immediate care were contacted and the project's dental provider network provided the necessary care. In addition, a New Orleans Resource Directory of Dental Providers was published to increase access. Additional resources are being sought to improve and expand the program in 2018. "It was a joy working with and educating the summer campers. They were engaged, inquisitive, and learned a lot about good habits for good oral health," said Dr. Hazel Harper, the national Project Director. Next year, priority scheduling will be given to the camps that were unable to be seen this year.



## NDA-CRT Members Receive Congressional Citations

National Dental Association Corporate Roundtable members Colgate-Palmolive, Henry Schein, Inc., and VOCO, received Congressional Citations from The Honorable Congressman Cedric Richmond, U.S. Congressman representing the 2nd District of Louisiana, which includes New Orleans. # Jamaica

Throughout the academic year, Howard Dental students fulfill the mission of the college by organizing and participating in several community service events, health screenings, and educational seminars targeting communities where access to care and education are lacking or absent completely. Global outreach missions have grown in popularity and participation among students, and this summer provided another opportunity for students to travel to Jamaica to do mission work geared towards dental care. During the summer of 2017, not only did students from Howard participate in missionary work in Jamaica, but also in Haiti, Pakistan, and Nigeria. With generous contributions and support from the Henry Schein Cares Foundation, the National Dental Association (NDA)-HEALTH NOW®, and Dr. Hazel Harper, Founding Director of the HEALTH NOW initiative, forty-seven students traveled to Jamaica and provided dental services to over 1,000 patients.

During a two-week span, two teams of dental students traveled throughout the country to areas where access to care is extremely limited. The students were accompanied by Dr. Reginald Salter, Assistant Professor in the Department of Comprehensive Dentistry, and several Howard dental alumni volunteers.

The first mission team visited Mandeville, Kingston, and Spanish Town during the first week and brought its own equipment to Jamaica. We are especially appreciative of the generous contributions and planning advice that Dr. Harper and the NDA staff provided in preparation for the trip. As a result of the donated supplies, the students were able to treat nearly 400 patients at Northern Caribbean University in Mandeville, Good Samaritan Inn, and Hiram Walters Clinic in Spanish Town. Logistics for the mission were arranged by Dr. Lincoln Edwards, dentist and President of Northern Caribbean University and the Jamaica Conference of Seventh Day Adventists in Jamaica. Many of the patients treated were receiving professional dental care for the first time according to the administrators at Good Samaritan Inn, a facility operated by the East Jamaica Conference of Seventh-day Adventists and members of the Adventist-laypersons Services and Industries. The second mission team visited Treasure Beach, Jamaica in collaboration with the Christian Dental Society (CDS). The CDS publicizes and facilitates dental mission trips around the world.

This year marked the fourth year Dr. Salter has led a group of Howard students working the CDS mission at the Helping Hands Dental Clinic. This was also a record breaking year for Team Howard as over seven hundred patients were treated in a four-day span. During both missions, students were supervised by dentists as they provided prophylaxes and oral hygiene instructions, restorative treatment, extractions, and limited endodontic therapy. D-3 dental student Angel Tucker said of the mission, “Days before I departed for Jamaica, I was shaking at the thought of treating my first patient. I was most concerned that I was not ready to deliver the quality of care that I truly wanted for my Jamaican brothers and sisters. With the encouragement and guidance of my day 1 partner/all-star professor Reginald Salter and my amazing D4 colleagues (shout-out Alexis Gilliam and Mike Jean-Baptiste), I was able to contribute to the total 702 patients served. The people of Jamaica have truly blessed my soul with their love, joy, and appreciation. I will forever love Jamaica”.

The ability to touch lives through service and reaching communities in need binds HU dental to the missions of the NDA, Seventh-Day Adventist Conference, and Christian Dental Society. Together, we are able to change lives- one smile at a time.



# & Pakistan

## Dental Missions 2017



In August 2017, a team of 15 dental professionals, and students, from Howard University College of Dentistry embarked on a journey to Pakistan to spend 5 days treating villagers and orphans. We were hoping to treat 500 patients but to our astonishment we provided dental care to around 2,000 individuals. The dental mission was funded by IMANA and hosted by Riphah University College of Dentistry in Islamabad. They provided staff, equipment, supplies, and everything else needed to make this dental mission a success. Our team at Howard University reached out to Dr. Hazel Harper from the National Dental Association (NDA) about the oral hygiene goodie bags needed for the underserved patients. NDA instantly made a generous donation of over 500 toothbrushes, 500 toothpastes, and 500 mouthwashes for adults and children. It was such a fulfilling experience for our team members to provide these individuals with their first toothbrush and toothpaste. We provided villagers and orphans with oral hygiene instructions about how to use a toothbrush and how to use mouthwash.

Every day we woke up around 6am to get ready in scrubs, book bags in hand, with everything we may need for the next 12 hours, and then we would leave for the dental camp site after a quick breakfast. Once we arrived at the designated location for that day, which usually took us over an hour, we set up dental chairs, materials, supplies and equipment in schools, tents and empty rooms in villages. The first 3 days of our dental

mission consisted of a mix of old and young villagers, the majority of whom had never seen a dentist. Our team performed several hundred extractions, periodontal treatment, and restorations for the villagers who were in desperate need of dental care. Last 2 days of

our dental mission were spent at Pakistan Sweet Home orphanage where we saw over 550 kids. This was one of the most rewarding feelings during this mission as we were working with little kids with no parents around them to hold their hands, but they were putting all their trust in us that we would take care of them. This dental mission would not be possible without the help and support of every single individual who put their faith in our team. It changed the lives of hundreds of individuals, and it impacted our lives as well while providing us a rich, rewarding, and a memorable experience for life.

# DENTAL MISSION



## The National Dental Association Teams Up with Tufts and the University of Haiti to Promote Oral Health

In April, members of the Tufts University School of Dental Medicine Chapter of the Student National Dental Association participated in a global service-learning trip to Haiti. This trip was led by members of the National Dental Association's (NDA) Global Oral Health Outreach Committee, which, is an American dental organization with a mission of promoting oral health equity among people of color. There were two main components to this trip. One component focused on laying the foundation for a formal relationship between Tufts University School of Dental Medicine and the University of Haiti School of Dentistry in an effort to promote future student and faculty exchanges between the two schools. The second component consisted of assessing the needs of a rural community in Leogane, Haiti and determining the feasibility of developing a dental prevention program in the community.

Over the years, the NDA has collaborated with the University of Haiti School of Dentistry in addressing some of the school's needs. This trip continued the initiative of the NDA in building capacity in Haiti for the promotion of oral health.

A delegation of Tufts students, faculty, and NDA members visited the University of Haiti School of Dentistry where they met with the Dean, faculty and students. Tufts dental students got to hear first-hand about the successes and challenges facing dentistry in Haiti and they also learned about the Haitian dental school's curriculum. Access to a dentist in Haiti is extremely difficult largely due to the low supply of dentists in the country. In Haiti, there are approximately 300 dentists for a population of over 10 million people. There is only one public dental school in the country, which is the University of Haiti School of Dentistry. Individuals in Haiti rarely have routine dental appointments. If one is fortunate enough to have access to a dentist, they often seek treatment only where there is pain or discomfort, which often results in an extraction of a tooth. University of Haiti dental students learned about novel ways to promote oral health in Haiti. Dr. Brian Swann, Chief of Oral Health at the Cambridge Health Alliance in Cambridge, Massachusetts, spoke to students about the importance of educating nurses and other health care workers about oral health and disease

prevention. Students and faculty were also exposed to evidence-based prevention strategies like fluoride varnish and dental sealants for children. Later during the trip, the students would use what they learned to provide treatment for children in Leogane.

On the way to Leogane, the delegation visited the Saint Rock Haiti Foundation where they provided oral health education to community workers and delivered fluoride varnish and other supplies to the dentists there. The students arrived in Leogane later that afternoon and prepared themselves for the next few days of service. The Rasin Foundation is a Massachusetts-based non-profit organization that provides health care, preventive services and works to eliminate poverty in Leogane, Haiti. In Leogane, the dental students from Tufts and the University of Haiti worked side-by-side in the Rasin Foundation's dental clinic and conducted screening exams, provided dental prophylaxis, fluoride varnish and sealants to children and adolescents. Through a very generous donation from Henry Schein Cares Foundation, they provided care to over 70 children.

They also provided oral health education to children and mothers. Pairing dental students from the Haitian dental school with Tufts dental students allowed the students to learn different approaches to providing dental care. Since the Haitian students could understand both English and Haitian Creole, the language barrier between provider and patient was overcome. In addition to rendering these services, presentations were given to over 30 local nurses about the prevention of dental disease. Nurses were taught about fluoride varnish and its role in preventing tooth decay in children. In small groups, dental students and faculty from both schools demonstrated how to conduct a dental screening exam and identified important landmarks in the mouth to focus on when screening for dental disease. Later, the next day, nurses were invited to observe the students and faculty as they provided treatment to children. Information regarding oral health status, number of decayed, missing, or filled teeth, and the treatment provided for each child was recorded.

By participating in this Tufts Global Service-learning (GSL) trip to Haiti, students understood the importance of learning about the history and culture

of Haiti prior to traveling to the country. Before this experience, students had to complete a GSL curriculum at Tufts which stressed the importance of serving with the local community rather than serving the local community with a "savior complex" mentality. Students learned about the importance of building relationships with stakeholders and working with local institutions such as the public dental school when designing an oral health program based on the needs of the community in the context of Haiti. Students understood that program sustainability and follow-up to care depended on this approach.

During the trip, the team visited the Haitian National Museum and historical landmarks in Port-au-Prince. Since this trip occurred during Holy Week, students had the opportunity to observe the Rara celebration which consisted of music and dancing in Leogane in celebration of Haiti's struggle and fight for independence. Additionally, students attended Easter Sunday Mass during the last day of the trip. These experiences allowed students to see a side of Haiti that is rarely advertised. These experiences helped to complete the picture of this complex and beautiful country.

With the service-learning approach students from both countries effectively worked together to deliver care to children who needed it the most. It was important for the students from Tufts to understand that service-learning requires understanding the needs of a community and working with members of the community to address those needs. The students are thinking of ways of building upon this effort and working with the University of Haiti in creating a sustainable oral health program in Leogane, Haiti. They are already planning for next year's trip.
