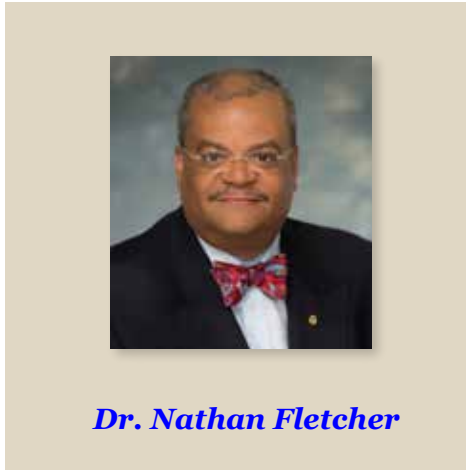
Bernie Sanders on the Comprehensive Dental Reform Act legislation that will be presented to the Senate very soon. My purpose was to ensure that key points are made within the legislation to address critical needs in all areas of oral health for the citizens of the United States and to make sure the communities and populations we serve were represented.

Several other organizations were present to provide their perspective on what was most important to their particular interest. There were representatives from Federally Qualified Health Centers, nursing home provider groups, dental societies, national dental associations; school based dental providers, community and national advocacy groups, and the American Dental Education Association, to name most.

The points made were the need to have the government sponsor low interest loans coupled with student loan repayment centers in dental provider shortage areas for five years to allow young dentists to begin a business in

one of these communities and settle in for five years while repaying their debt as well. Another point was to ensure that adequate funding was made available for Title VII to assist in educating underrepresented groups for dental school. Medicaid funding was discussed as well. We discussed the traditionally recognized underserved groups with more discussion on Adult Medicaid and services for seniors. One point made was that once a year volunteer services is not a strategy to address the true need for oral health services for the most in need. We can do better and should.

It is important to be at the table for discussions of this nature to make sure our voice is heard. If you have opportunities such as this to make a difference you should actively participate and speak on the NDA positions on the issues critical to oral health concerns for those who have the least. Let the NDA office know when you have engaged with legislators and provide an update such as this to ensure that our members know what is going on.



Ester Named Assistant Dean for Diversity, Equity and Inclusion



Ann Arbor, Mich., May 9, 2018

Dr. Todd V. Ester has been appointed Assistant Dean for Diversity, Equity and Inclusion for the School of Dentistry. The five-year appointment, approved by the University of Michigan Board of Regents at its March meeting, extends through March 31, 2023. He also will hold an appointment as Clinical Assistant Professor of

Cariology, Restorative Sciences and Endodontics.

Ester's new appointment is an extension of his role since 2014 as the School of Dentistry's Director of Diversity and Inclusion. His responsibilities include leadership and initiatives that increase diversity and cultural awareness at the school, across campus and at the state and national levels. As an advisor to the school's leadership, he focuses on creating a supportive environment to serve a diverse community of patients, students and faculty. He advocates on institutional issues that relate to diversity, cultural sensitivity and health equities to support cultural

competency. His work as DEI director has attracted four university-level program grants.

"Todd continually demonstrates strong leadership as a superb mentor, role model and advisor for his students and colleagues," said Dean Laurie McCauley. "He leads with inspiration and enthusiasm and will play an important role in the advancement of the school's strategic plan as it relates to cultural awareness. He has shown great engagement and passion with every initiative and has received high acclaim at the University level. I look forward to his ongoing contributions to our diversity programs and his continuing participation on the leadership team."

Ester earned his DDS in 1994 and his MS in endodontics in 1999, both from U-M. In 2007, he earned his master's in health education from the University of Pacific. He was a lecturer and recruitment officer for the dental school's Minority Affairs office before becoming the school's Director of Multicultural Affairs from 1999 to 2006. After leaving to focus on his private endodontics practice in Southfield and Ann Arbor, he rejoined the school in 2014 as its DEI director. He has served multiple roles with the American Dental Education Association and was a member of the Delta Dental of Michigan Board.

As a reminder, each chapter needs to submit a copy of their bylaws by June 30, 2018. The National Dental Association bylaws state that each component or constituent society or chapter's bylaws and constitution should not be in conflict with the National Dental Association's constitution and bylaws. It also states that each component and constituent chapter should file a copy of their current bylaws with the NDA Executive Director of the association.

All members, chapters, and officers that specifically represents the National Dental Association, should be consistent with all published policy papers. Any written correspondence that expresses an opinion on any subject that has a written policy statement, should be sent to the National Office for approval, prior to offering that statement for public consumption. It is extremely important that we speak with ONE VOICE as an organization, and that the public is clear about our position. When statements or correspondence differ from the House of Delegates approved statements, it sends an inconsistent message, which could in turn damage relationships inadvertently.

The NDA leadership encourages involvement of local chapters, and they understand there may be different opinions or points of view about a subject or policy, but we can only speak with one voice and with a consistent message if we truly wish to be heard.
